MANAGERS' COMMENTARY

With global markets falling, many of the top contributors to portfolio performance were stocks that were considered by markets to be more defensive in nature. Among these was DSM, the Dutch science-based company which specialises in human and animal nutrition products. There was no significant newsflow over the month, but DSM's revenue exposure is more defensive relative to the materials sector. US tech giant Microsoft was another strong performer, meanwhile, Cisco Systems, a new addition to the portfolio, was the most notable positive for the month.

On the other side, auto-parts maker Continental was the most significant detractor. The firm delayed its AGM, which could put the dividend at risk. Guidance for the year was also cut significantly from prior expectations. It was lowered even further later in the month - and then withdrawn in its entirety as a result of significant COVID-19-related disruption to the auto industry. Aircraft manufacturer Airbus also weighed on returns. It has seen significant disruption to both production and its airline customer base, which puts the dividend at risk as the industry moves to conserve capital. Brick maker lbstock was another negative. Production was halted alongside site closures of key homebuilder customers. The dividend has been suspended and forward guidance removed.

In terms of portfolio activity, we sold Truist Financial to fund an increase in Bank OZK, because we had more confidence in the latter's ability to weather any economic dislocation from the COVID-19 outbreak, due to it having a better-capitalised balance sheet and higher margins. Other sales over the period were Airbus and Continental. Cisco Systems was added to the portfolio during the month. We had previously sold put options and the stock was exercised to us as the options expired.

Morningstar Rating for Funds

Morningstar rates funds from one to five stars based on how well they've performed (after adjusting for risk) in comparison to similar funds. Within each Morningstar Category, the top 10% of funds receive five stars, the next 22.5% four stars, the middle 35% three stars, the next 22.5% two stars, and the bottom 10% receive one star. Funds are rated for up to three time periods—three-, five-, and 10 years—and these ratings are combined to produce an overall rating. Funds with less than three years of history are not rated. Ratings are objective, based entirely on a mathematical evaluation of past performance. They're a useful tool for identifying funds worthy of further research, but shouldn't be considered buy or sell recommendations.
