MANAGERS' COMMENTARY

The portfolio's largest position Microsoft continues to perform well. While there was no specific catalyst for the strong performance during August, it remains a beneficiary of increased adoption of working from home, as its productivity suite and 'Teams' products help organisations to allow employees to be productive while working remotely. US multinational power management company Eaton has also continued to perform well following strong second-quarter results at the end of July despite the difficult operating environment. Meanwhile, US semiconductor producer Broadcom was another positive as sales related to hyperscale data and cloud customers were expected to continue to be robust in advance of its earnings report in early September.

On the other side, Philips was a drag on portfolio performance after the US HHS (Health and Human Services) cancelled part of its ventilator contract (signed in April as part of a response to Covid-19). This led to the company slightly paring back its margin assumptions for the balance of the year. Elsewhere, although results for the US technology multinational Cisco were above market expectations, the company signalled that its recovery was likely to be more drawn out than previously thought as corporates deferred spending decisions, especially regarding networking hardware. Samsung Electronics fell slightly during August as expectations around the rate of a pricing rebound in some if its key end markets, such as memory, were pushed out to 2021.

In terms of portfolio activity, we sold our position in Leggett & Platt, which is exposed to the auto and bedding end markets, as we believed that a recovery in these end markets was being fully reflected in the shares after a sharp recovery from the market lows seen in March.

Morningstar Rating for Funds

Morningstar rates funds from one to five stars based on how well they've performed (after adjusting for risk) in comparison to similar funds. Within each Morningstar Category, the top 10% of funds receive five stars, the next 22.5% four stars, the middle 35% three stars, the next 22.5% two stars, and the bottom 10% receive one star. Funds are rated for up to three time periods—three-, five-, and 10 years—and these ratings are combined to produce an overall rating. Funds with less than three years of history are not rated. Ratings are objective, based entirely on a mathematical evaluation of past performance. They're a useful tool for identifying funds worthy of further research, but shouldn't be considered buy or sell recommendations.
