## **COOKIES**

This cookie policy sets out the basis on which STS Global Income & Growth Trust plc's (**we**, **us**, **our**) website, <a href="https://www.stsplc.co.uk//">https://www.stsplc.co.uk//</a> (**our website**) uses cookies and similar technologies.

Our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good browsing experience when you visit our website and allows us to make our website more efficient. By continuing to browse our website, you are agreeing to our use of cookies.

## How cookies work

Cookies are small text files that are sent to and stored on your browser or the hard drive of your computer, smartphone or other device used to access the internet, when you visit certain websites. We use cookies to enable and improve certain functions on our website and gain feedback on how our website is used.

You can block cookies by activating the setting on your browser that allows you to refuse the setting of all or some cookies. If you choose to switch certain cookies off or block cookies, it may affect how our website works.

## Our use of cookies

We have categorised cookies based on the categories found in the ICC UK Cookie guide.

- Strictly necessary cookies. These are cookies that are required for the operation of our website.
- Analytical/performance cookies. They allow us to recognise and count the number of visitors
  and to see how visitors move around our website when they are using it. This helps us to
  improve the way our website works, for example, by ensuring that users are finding what they
  are looking for easily.
- Functionality cookies. These are used to recognise users when they return to a website (for example, their choice of language or region).
- Targeting cookies. These cookies record a user's visit to a website, the pages they have visited and the links they have followed. This information is used to make websites and the advertising displayed on them more relevant to users' interests. This information may also be shared with third parties for this purpose.
